- Employee Empowerment & Accountability




MVA Goals

Procurement Modernization Highlights

Effective October 1, 2017:

- Small Procurement threshold limit increased from \$25K to \$50K and Small Construction procurement ceiling to \$100K
- Procurement method preference is Best Value
- Streamlined MBE certification process
- Architectural & Engineering (A&E) reform:
 - Optional Expression of Interest Phase; and
 - Elimination of the Transportation Professional Services Selection Board



Small Business Reserve (SBR) Procurements

eMaryland Markplace (eMM) is the online procurement system that provides registered vendors with easy access to State procurement information and automated notification of new procurement opportunities.

Solicitations designated as "SBR" allows small businesses to compete only against other small businesses and can only be awarded to a certified SBR vendor.

eMM allows vendors the ability to:

- Complete the Small Business Reserve (SBR) self-certification
- Receive notice of bid opportunities
- Search for contracting opportunities
- Submit bids electronically
- Obtain bid results online

FY17 MDOT MVA SBR Overview

- Total Paid to SBR Contractors under a Designated SBR Procurement \$3.1m
- Total Paid to SBR Contractors under a non-designated SBR Procurement \$8.4m
- Total Number of SBR Contractors receiving award and payments 79
- Total Awards and Payments to SBR Contractors = \$10.7m
- Percentage of all SBR Payments = 36%
